Treasurer's Report – Anne Bourner

Librarian's Report – Susan Colbert

A discussion brought up the questions of the new carpet that has just been laid and the concern for stains, the probable question of if coffee then why not soda, etc., and the overall logistics. No action was taken on the suggestion.

- 3. Susan Colbert received information that the mileage rate for business travel went up to \$0.57 per mile. Steven Gerlach moved and John Clendenin seconded that the Board raise reimbursement for business mileage to that rate. The motion carried unanimously.
