B. The following grants were awarded to the Sparta Public Library:

Per Capita Grant - \$6081.08 - July 1, 2024 (Standards will be reviewed as in the past.) Technology Grant from the IL State Library - \$12, 500.00 - June 12, 2024-June 30, 2026.

C. The purpose of the Technology Grant is to improve the library infrastructure and will include the following purchases:

3 patron computers Replacement of old staff printer replacement of 20 yr old telephones wiring for children's computer plus correction of wiring under computer carrel

- E. The library will continue to offer non-residents a library card for \$63.00/year.
- F. The Sparta Public Library is required by the DOJ to make their websites and moble applications

accessible for people with disabilities by April 2026.

- G. Aspen Discovery is an open source search system which is library specific. It is presently integrated into the ILS system which includes Hoopla and cloudLibrary.
- H. The brush piles and limbs in the front area of the library will be removed by the city.
- I. There was a discussion and approval of an Open House to introduce the public to the new renovations to the library. The date selected is Saturday, November 2, 2024 from 1-3 pm.

A motion was made by Amy Kloos and seconded to accept the librarian's report. The motion was voted on and passed unanimously.
